

PROTEST AND INVITATION TO A NEW MISSION!



Dear Members of the EU Parliament!

During the debate and resolutions of the EU Parliament on the state of the media and democracy in Slovenia, we express astonishment and indignant protest against the actions of liberals, greens, socialists and others, who unanimously repeated un-argued condemnations against the Republic of Slovenia and its government. get acquainted with the real state of affairs. The debate that the above-mentioned deputies led after their visit to Slovenia was incredibly biased and even below the level of the opposition of our Slovenian Parliament. The discussion was not based on facts, but on lies and snobbery, which is causing discord not only in Slovenia, but in the whole of Europe. The unfortunate mission that visited Slovenia will unfortunately be written in the history of EU parliamentarism as an extreme ideological inquisition, with the intention not to help Slovenia, but to discredit it and escalate chaos, which can only result in a new Slovenian split and street riots.

We never imagined that such a low, primitive and exclusive way of debate is possible in the 'highest temple' of EU democracy, which cannot be in honor of the very well-paid professional political elite you represent and who otherwise values himself and declares himself progressive, but it turned out to be in fact extremely reactionary and far from what she declares herself to be. It is about a fateful exclusion that was once, three-quarters of a century ago, described by the famous economist and sociologist Nobel laureate August Friedrich von Hayek in his book FATEFUL IMAGINATION. This does not lead to progress, as you call it, but to the collapse and decline of democracy. With the latest new attempts to censor Christianity and natural gender identity, it is even leading to the downfall of European civilization.

To understand: **THERE IS NO DICTATORSHIP IN SLOVENIA**, we are led to the **DICTATORSHIP** by unsubstantiated accusations of those who, with the help of the street and potentiating dissatisfaction, try to achieve chaos and overthrow the executive branch in a non-parliamentary way, according to the technology used by Slobodan Milošević in the former Yugoslavia. That is why we once again call on the EU Parliament to take action in its ranks against such non-democratic pressure to overthrow - not only Slovenia, but any democratic and sovereign state! Europe is not a federation but, according to the provisions of the accession treaties, a union of equal sovereign states, among which Slovenia really has very big problems - not with the executive branch - but **with the judiciary and the prosecutor's office**, which in the 21st century **even uses secret trials** and at the same time, it is resolutely resisting public scrutiny via the digital route.

Honorable Members of the EU Parliament, we urge you that the EU Parliament delegation visit Slovenia again to **carefully investigate the situation in the judiciary and the authorities and the Prosecutor's Office**, but in a way that will truly justify the delegation's visit and be worthy of a fair resolution.

Here is a list of the most exposed cases that the delegation, which in Slovenia unfortunately did not even dream of: *from incredible murders in courtrooms, to electoral fraud in otherwise formal and non-democratic elections. We draw attention to the cases of Ivan Kramberger, Depala vas, Patria and the cases of Franc Kangler, attacks on journalists - Miro Petek and even physical attacks, during this year's protests. The worst thing that is happening to us is crime in courtrooms - the victim is the 'substitute killer' dr. Milko Novič, and in this connection the judiciary is intimidating the honest judge Zvezdan Radonjić. A judge who*

dared to judge impartially, comprehensively and fairly. We are not even explaining in detail the case of laundering Iranian money worth 1 billion euros in Slovenia. We must also remind of the numerous electoral frauds in the 2009 parliamentary elections and the 2018 local elections in Ljubljana, which the judiciary and prosecutors do not want to prosecute. Because scams and fraudsters, even according to their own statements, are systemically inviolable and protected. The highlight is the latest revelation of cases where important judges and prosecutors do not have a university degree and / or lack professional qualifications - a mandatory (DPI) state exam. In Slovenia, this was the subject of an investigation years ago, which was prevented by the then judicial authorities. In the litigation on such violations, the judge then unlawfully decided that the state bar exam is not a condition for performing the judicial service¹. In short, there is no rule of law in the Republic of Slovenia, but we have a completely inadmissible self-service judiciary, for which there is of course a deep parastatal interest, ie to recruit as many public revelation of their sins. We emphasize, therefore, that threats to journalists do not come from the government, the executive branch, as you mistakenly imagine, but from the judicial branch of government, which in transition has remained a completely untouched. This caste of arbitrary and privileged people who live with impunity over the rest of the population has remained completely untouched.

Of course, all these statements are far from all, they are just a brief sketch of the undemocratic situation and practices in the Slovenian judiciary and, of course, the prosecutor's office, which the EP mission should carefully and thoroughly consider and sanction, and not unprofessionally ignore.

Ladies and gentlemen, you have a completely wrong and distorted picture of the situation in Slovenia: seemingly independent media - such as RTVSLO and STA, as well as leading print media - Delo, Večer and Dnevnik, do not serve democracy and the public, but mostly maintain status quo.

There is no government dictatorship in Slovenia, but CENSORSHIP with the active help of the opposition. In March 2020, it lost power "by an incredible coincidence", but now, through the export of "its revolution", Brussels and the EU are convincing the parliament about the threat to democracy in Slovenia. Democracy is not threatened by the government but by the judiciary and the prosecution, along with those media that the EU mission generously takes to protection.

Ladies and gentlemen, MEPs, elected representatives of the people of all EU Member States. We call on the EU Parliament to reject the biased LIBE report and set up a new commission, with a new delegation that will be composed democratically, that is, in a truly representative and plural way. A delegation that will seek, rather than arbitrarily, construct a priori 'truth'. We call on the leadership of the EU Parliament to publish our protest in the form of a petition on the official website of the EU Parliament and in the newspaper *Politico*, as well as in the *Official Journal of the European Union*. In short, we urge you to tackle the real problems of democracy and help rehabilitate Slovenia's biggest problem - **the judiciary and a very unbalanced media structure**. The atmosphere of mistrust and schism mentioned in the report is not the result of the work of the current Slovenian government, which gained legitimacy in the elections, but of those who, although incompetent, would like to rule again.

At the same time, we urge EU MEPs to support the digital transformation of the Slovenian judiciary, which is currently resisting this. It is about surveillance and digital public presence in courtrooms. Regarding delegated European prosecutors, we expect that the EU prosecutor's office will give priority to investigating the Stožice project of Ljubljana Mayor Zoran Janković, who publicly boasts that nothing can happen to him in Slovenian court as long as he opposes Janez Janša.

On behalf of the democratic Slovenian public, we therefore call on the EU Parliament to take a corrective exam. Despite the EU's mission, which has just failed, we have not lost hope for a legal and fairer society, which we can also secure together with the help of the EU and its institutions. The first condition for this is that the EU parliament ends the ideological war at the behest of the handicapped Slovenian opposition,

which is unable to bear the loss of power. Democracy is not endangered in Slovenia, on the contrary - it is too much for those who want to overthrow it by force and abuse regulations.

DEMOCRACY IS NOT THREATENED by the current Slovenian government, but by the opposition, its emptiness, disunity and incompetence, when it uses the national disaster - the pandemic for its political return. Slovenia's presidency of the EU minimizes and hinders it at every step and censors it through its media. In Slovenia, unfortunately, the democratically conceived institutions - the Constitutional Court, the Supreme Court and the Administrative Court and the Court of Audit - have almost completely turned into their opposite, **a means of maintaining the status quo and depleting taxpayers**, but in fact of restoring and preserving surviving structures. totalitarianism. The threat of deprivation of EU budgets for growth and recovery is a measure of degenerate and alienated EU bureaucracy. We call on the deputies, who are elected representatives of the people, to decide according to democratic standards and to reject any pressure on the independent and sovereign state of Slovenia. We cannot accept that, instead of Belgrade, we are ruled in the same way by an unelected and illegitimate Brussels bureaucracy.

Honorable Members of the EU Parliament. We **call on you to set up a new commission and send a new delegation** to Slovenia without pre-determined positions. We cannot agree to methods of pogrom and evasion of the facts if the facts are not in line with the expectations of the Head of Mission. We will definitely present you with many unknown facts and examples. Of course, we will also record the visits and conversations, because we want all-round transparency and we are at your disposal anywhere and anytime. We suggest that we meet with the new democratic delegation of the EU Parliament as soon as possible, and in January 2022 at the latest in Ljubljana, in the House of Europe.

In the end, we emphasize: we are out of our minds, we are left with only the public - also the European and parliamentary public, which is supposed to be represented by mature and reasonable people - parliamentarians, not the new instigators of the Slovene schism!

Ladies and gentlemen, we reckon that you are prudent and honest people who know how to separate the grain from the weeds and rise above prejudices and political indoctrination for the abuse of democracy. That is why we are writing to you and reminding you of the 'other side of the moon', which the self-sufficient Brussels bureaucracy is unfortunately unable to see.
